FIRST AMENDMENT TO INTERAGENCY AGREEMENT

THIS AMENDMENT is entered into by and between the COMMONWEALTH OF PENNSYLVANIA, acting through the COMMONWEALTH FINANCING AUTHORITY ("CFA") and PENNSYLVANIA FISH & BOAT COMMISSION, with an address at 1601 Elmerton Avenue, Harrisburg, PA 17110 ("PFBC").

BACKGROUND:

CFA and the PFBC have heretofore entered into an Interagency Agreement (the "Agreement"), for the provision of a grant in the amount of Nine Hundred Eighty Thousand Dollars (\$980,000.00) for renovation to the Lake Nessmuk Dam, excavation/grading, and inspections (the "Project"); and

The PFBC has requested an extension of the termination date of the Agreement for twelve (12) months, from June 30, 2012 to June 30, 2013, in order to allow sufficient time in which to complete the Project; and

CFA has determined that this extension is necessary for the success of the Project and that the extension will not increase the amount of Funds payable to the PFBC under the Agreement.

NOW, THEREFORE, for and in consideration of the foregoing premises and the mutual promises hereinafter set forth, the parties hereto agree, with the intention of being legally bound hereby, to amend the Agreement as follows:

1. The foregoing preamble and clauses are incorporated herein and made a part hereof.
2. The termination date of the Agreement shall be extended from June 30, 2012 to June 30, 2013.
3. Unless otherwise defined herein, the terms used herein shall have the same meanings as set forth in the Agreement.
4. All other terms and conditions of the Agreement not expressly amended or modified herein shall continue in full force and effect.
