CHANGE SUMMARY:

In accordance with Section 35, Changes, of the COSTARS Contract Standard Terms and Conditions, Section 8. Ancillary Services of the COSTARS Contract Special Terms and Conditions is revised to remove the "Installation" provision. The COSTARS Contract Special Terms and Conditions are replaced. This change shall be effective immediately. Hereafter, any Purchaser requiring installation services must procure those services separately by following their regular procurement requirements and any applicable laws.

In addition, the Steel Products Procurement provision is now contained in Section 9. and reads as follows:

Section 9. Steel Products Procurement Act – The Steel Products Procurement Act, 73 P.S. §§ 1881-1887, and the Trade Practices Act, 71 P. S. § 773.101 et seq., which place restrictions upon the source of certain steel, cast iron and aluminum products allowed to be used in the performance of public agency contracts may be applicable to purchases under this contract. At the time a quote is requested, the governmental entity Purchaser shall inform the suppliers whether this Act is applicable. Failure by the Purchaser to do so, however, does not eliminate or otherwise affect the applicability of the laws and requirements to the purchase. Governmental entity Purchasers may not use this contract to avoid applicable legal requirements. It is the responsibility of each governmental entity Purchaser (and their legal counsel) to determine what legal requirements or limitations apply and whether or not the COSTARS contract is appropriate for a particular purchase.

If a Contractor does not wish to abide by the changed terms, it may opt out of the contract by providing written notice to the Commonwealth.
