# We hereby submit specification and/ or quotation for:

In accordance with our job site visit on 10/08/12, we will perform the following scope of work on Tyson Hall.

**REMEDIAL CAULKING:** At the above referenced project, all existing caulking will be removed from the joints listed below, and these joints will be thoroughly cleaned of all surface dirt, dust, and sealant residue. Next, we will insert the proper sized backer rod into the prepared joint, to a depth required to achieve the best possible joint dimension field conditions allow. We will then seal these joints with a premium grade Sika 15 Im polyurethane sealant in a color chosen by owner. The caulk joints will be neatly tooled to a clean, watertight finish.

## **CAULK JOINTS TO BE ADDRESSED:**

• (9) expansion joints

# **CLARIFICATIONS**

All areas are to be cleaned of any excess scrap or material and left in a clean, safe condition as soon as possible after completion of the work area. All construction debris is to be removed from the site by the contractor.

The owner must approve the locations for all construction material and dumpsters left in place overnight. All other construction equipment and vehicles are to be parked in areas designated by the project manager.

The appearance, conduct, and language of the contractor's employees shall not be offensive, abusive, or objectionable to the occupants of the building.

Normal working hours are between 7:00 A.M. To 3:30 P.M. Monday through Friday. This proposal assumes all work will be performed during normal hours.

All pedestrians and others without specific clearance to be within the work area will be re-routed during the course of work. For safety, all tenants will be restricted from entering the work area for any reason unless previously agreed upon by the project manager.

All existing masonry, paint, sealants, and other associated building materials are free of lead, asbestos, and other hazardous materials.

- Winter/ cold weather protection

- · Permit fees are not included in this quotation
- Performance and maintenance bonds are not included in this quotation
- All pre-construction testing
- The testing, removing, and handling of any hazardous materials

- Any unforeseen buried items such as conduit, re-bar, plumbing, post-tension cables, etc.
