**PROJECT DESCRIPTION**

The CONTRACTOR proposes to pay for the operational costs for year 6 of the Enterprise Zone and completion of an expanded cluster-based strategy within the County of Huntingdon.

**Please Note: Prevailing Wage requirements are generally applicable to grants for construction, demolition, reconstruction, alteration, repair work, renovations, build-out and installation of machinery and equipment in excess of \$25,000.00. **SPECIAL CONDITIONS**

No payment shall be made under this CONTRACT for Fiscal Year 2008 activities (\$75,000) until the DEPARTMENT receives and accepts a revised Resolution containing the appropriate "ineligible expenditures" language.

The CONTRACTOR must perform a project audit at the completion of the contract or when all funds are expended. An attestation that the matching funds referenced in the contract budget were received and expended in accordance with this contract must be included in the audit report.
