Dear Ms. Fake:

The Commonwealth is exercising its option to renew the Telecommunications Managed Services contract between the Commonwealth of Pennsylvania and MCI Worldcom (dba Verizon Business) (the "Contract"). Section 1 of the Contract states:

This Contract shall be effective commencing on the Effective Date as defined in Paragraph 1(a) of the IT Terms and Conditions and shall terminate seven years after the Effective Date, unless extended by the Commonwealth Project Office prior to that date.

Section 1(b) of the IT Terms and Conditions, incorporated into and made part of the Contract as Attachment A, further states that:

The Commonwealth may, in its sole discretion, renew the Contract for three 1-year periods, or any combination thereof, on the terms and conditions in force at the date of the renewal and utilizing pricing to be negotiated but consistent with and no less favorable than the pricing in effect at the date of the renewal.

In consideration of the price reductions, credits, and new services offered by Verizon Business as summarized in your letters to Secretary Minnich dated October 13, 2016, the Commonwealth is renewing the Contract for three (3) years. The new termination date of the Contract will be October 30, 2019. All rate reductions and modifications to the services available through the Contract will be implemented through the Contract change control procedures.

The Commonwealth is requesting your acknowledgement of the Contract renewal. Please confirm your acknowledgement by completing the bottom section of this letter and emailing a copy to me by close of business on October 24, 2016.
