AMENDMENT #2 GRANT AGREEMENT NO. 4100077277

This Amendment No. 2 to Grant Agreement No. 4100077277 is made between the Commonwealth of Pennsylvania, Department of Human Services ("Department"), and ModivCare Solutions, LLC (formerly LogistiCare Solutions, LLC) ("Grantee").

WHEREAS, the Department and Grantee are parties to Grant Agreement No. 4100077277 ("Agreement"), effective March 1, 2017;

WHEREAS, pursuant to the Agreement, Grantee provides Medical Assistance Transportation Program ("MATP") services to Medical Assistance beneficiaries residing in Philadelphia County;

WHEREAS, the term of the original grant was March 1, 2017, to February 29, 2020, with the discretion to extend for one additional two-year period. The Department exercised its one additional two-year period option which extended the grant term to February 28, 2022;

WHEREAS, the Department opted to extend for 90 days through May 29, 2022, and then executed Amendment #1 to the Agreement on May 10, 2022, which extended the term for nine months to February 28, 2023, with the option to extend for two additional three-month periods;

WHEREAS, the Department exercised both optional extensions to make the grant term effective through August 31, 2023;

WHEREAS, the Department has exercised its option to extend the grant for an additional 90 days after the end of the grant term pursuant to the terms and conditions of the Agreement in order to prevent a lapse in services; and

WHEREAS, the parties have identified the need to further amend the Grant Agreement to prevent a lapse in MATP services until a new grant agreement for such services is in place.

NOW, THEREFORE, the parties, intending to be legally bound, agree as follows:

Paragraph 1 of the Agreement is DELETED and REPLACED with the following:

1. The term of this grant shall be from December 1, 2023, through August 31, 2024. The Department, in its sole discretion, may extend the Agreement on the same terms and conditions for three additional six-month periods. The Department will notify the Grantee of its election to exercise its renewal option in writing at least 15 calendar days prior to the expiration of the term. The Department's right to exercise any such option shall not expire unless and until the Grantee has given the Department written notice of the Department's failure to timely exercise its option and has provided the Department with ten calendar days opportunity from the Department's receipt of such notice to cure the failure.

2. Rider 1 Payment Provisions Section B is amended with the following:

For the period covered by Amendment #2 (December 1, 2023, through August 31, 2024), the Per Member Per Month rate is 6.35 (\$5.65 + \$0.70 driver bonus).

- 3. This Amendment #2 will be effective once all approvals are obtained, and the amendment has received all signatures required by Commonwealth contracting procedures. This Amendment #2 shall continue in effect for the entire Agreement term.
- 4. Except as expressly modified by this Amendment #2, all other terms and conditions of the Agreement shall remain in full force and effect.
